The regular scheduled meeting of the Board of Trustees of Turtlecreek Township was held on June 26, 2012 at 8:00 a.m. with the following person present:

The meeting opened with Mr. Sams leading the Pledge of Allegiance.

The minutes of the previous meeting were received by the Trustees prior to the meeting for review. Since there were no additions or corrections, Mr. VanDeGrift moved for acceptance, seconded by Mr.Sams. All were in favor and the minutes were approved as written.

Promptly at 8:00 a.m. the annual budget hearing was held. The Trustees received the budget proposal prior to the meeting for review. After a brief discussion, Mr. VanDeGrift moved for the acceptance and forwarding the proposal to the county auditor, and was seconded by Mr. Jones. **Resolution 12-06-03** concerning the above budget hearing/proposal was approved. The Fiscal Officer informed the Trustees that Mr. Wilson and she met with Duke Energy representatives regarding the new automated metering that will go into effect in the fall. The information will be added to the township's website.

A donation request for the Warren County 4-H Horse Advisors was received. The Advisors are asking for \$250.00 to replace the benches at the North end of the riding arena. Mr. VanDeGrift made a motion for the donation of \$250.00. Mr. Jones seconded the motion. All voiced a "YEA" vote and the motion was passed.

The Fiscal Officer reported that the properties on Hart Road and St. Rt. 350 were submitted for consideration of the Moving Ohio Forward Grant.

Mr. Jones informed the Trustees that a question was raised regarding the property between Bowman school and the church. The ditch line is being mowed by the school and it is believed that the property is the townships. Mr. VanDeGrift will check with the church that leases the property from the township to see if in fact they should be mowing the ditch line.

Mr. VanDeGrift informed the Trustees that he has contacted two businesses for donation to the Warren County Township Associations 5k Walk/Run. Mr. VanDeGrift requested an executive session to discuss personnel.

Mr. Sams reported that OKI has completed their 25 year plan and this information can be found on their website.

Department Reports:

Fire/EMS: Steve Flint, Fire Chief, Mike Jameson, Assistant Fire Chief, and Erin Monroe, EMS Chief reported fire and EMS incident information. Chief Flint informed the Trustees that the new squad is completed and will be ready for service soon.

Road and Bridge: Larry Wilson, Road Supervisor, presented his weekly department activity reports completed since the previous meeting. Mr. Wilson informed the Trustees that the Reserves of Timbercreek is scheduled for a walk through on June 28, 2012 at 10 a.m. Mr. Wilson reported that the repair work on Liberty Keuter has been completed and is ready for chip seal. The City of Monroe has requested the assistant of the township with boom mowing. Mr. Jones made a motion to assist with the mowing. Mr. Sams seconded the motion. All voiced a "YEA" vote and the motion was passed.
