#### **TURTLECREEK TOWNSHIP BOARD OF TRUSTEES**

#### ON JANUARY 28 14

The regular scheduled meeting of the Board of Trustees of Turtlecreek Township was held on January 28, 2014 at 8:00 a.m. with the following person present:

TRUSTEES: Dan Jones, Jonathan D. Sams, and Jim VanDeGrift (Left at 9:30 and returned at 10:30) CHIEF FISCAL OFFICER: Tammy Boggs

GUEST: Steve Flint, Michael Jameson, Larry Wilson, Jon Paul Campbell, Alan Wolfson, David Fornshell, Michael Shaffer, Jennifer Niehaus, Neil Tunison, Kurt Weber, and Bruce McGary.

The meeting opened with Mr. Jones leading the Pledge of Allegiance.

The minutes of the previous meeting were received by the Trustees prior to the meeting for review. Since there were no additions or corrections, Mr.VanDeGrift moved for acceptance, seconded by Mr. Sams. All were in favor and the minutes were approved as written.

Mr. David Fornshell, Warren County Prosecutor's Office, presented his 2014 annual report

Mr. Bruce McGary, Warren County Prosecutor's Office, presented information to the Trustees regarding the vacate request for Mabrey Road. The Trustees will continue this issue until the next meeting.

Ms. Boggs, Fiscal Officer, requested a resolution to add vacation hours for part time employees for the year ending 2013 at a rate of .0385 per hour worked. Mr. Sams made a motion to add the vacation hours. Mr. VanDeGrift seconded the motion. All voiced a "YEA" vote and the motion was passed with **Resolution 14-01-06.** (A copy of the resolution is included in the minutes).

Ms. Boggs informed the Trustees that a bill has been received for legal services provided to the 123/I71 JEDD Board of Directors in the amount of \$2,468.09. The bill will be split with the City of Lebanon and the fees will be reimbursed once that JEDD is receiving money. The amount the township will need to pay is \$1,234.05. Mr. VanDeGrift made a motion to pay these fees. Mr. Sams seconded the motion. All voiced a "YEA" vote and the motion was passed with **Resolution 14-01-07.** (A copy of the resolution is included in the minutes).

Ms. Boggs informed the Trustees that the township needs to replace six (6) desk top computers and one (1) lap top computer. The cost to replace these computers will be \$576.48 per desk top and \$479.99 for the lap top. The total cost will be approximately \$3,938.87 from Dell computers. Mr. Sams made a motion to purchase the computers and requested that we check with employees to see if they would prefer a lap top. Mr. VanDeGrift seconded the motion. All voiced a "YEA" vote and the motion was passed with **Resolution 14-01-08**. (A copy of the Resolution is included in the minutes).

The township received from Warren County Zoning Department the Re-zoning Case #2014-01 164.3304 acres on State Route 63 to PUD. The Trustees discussed this rezoning and will issue a letter to the zoning department that they would request the following: (1.) Developer to submit landscape plan and standards as part of phase I, (2.) Developer to submit design and architectural standards as part of Phase I to include among other standards: Full masonry wrap, No vinyl, At least 12" overhang, At least 1 overhanging porch area and Roof pitch, (3.) Reserve space for Bike Path, and (4.) Design standards for commercial area, No strip malls/plazas.

Mr. Sams updated the Trustees regarding fire arms in the township building. No fire arms are allowed inside the township building. EMS personnel are allowed to carry fire arms, with permit, but must not bring them into the township building.

#### Department Reports:

Fire/EMS: Steve Flint, Fire Chief and Mike Jameson, Assistant Fire Chief reported fire and EMS incident information. Assistant Chief Jameson provided information to the Trustees regarding the 911 app for smart phones for the fire department. The app will run \$10.50 per person per year for fifty (50) employees. Chief Jameson explained how this app will work and be a benefit to the department. Mr. Sams made a motion to approve the cost of this app for all employees. Mr. VanDeGrift seconded the motion. All voiced a "YEA" vote and the motion was passed. Assistant Jameson also informed the Trustees that he would like to look into obtaining tablets for the two (2) suburbans. The Trustees gave their approval to investigate the tablets. Assistant Chief Jameson also requested that the department look into provide a reimbursement cost for the EMS employee that works the daily schedule. The EMS employee uses their cell phone to coordinate the schedule and Assistant Chief Jameson feels that the township should reimburse this employee. The cost of the service will be obtained and provided at the next meeting for discussion. Assistant Chief Jameson informed the Trustees that the cost for the rescue team's helmets will be more than expected. The Trustees approved the additional cost as it is a necessity for the team members.

Road and Bridge: Larry Wilson, Road Supervisor, presented his weekly department activity reports completed since the previous meeting. As per a legal opinion from the prosecutor's office the township does not have the ability to place "no thru signs" on the township roads. Mr. Sams made a motion to rescind the Resolution 13-11-06 that authorized the placement of these signs. Mr. VanDeGrift seconded the motion. All voiced a "YEA" vote and the motion was passed with Resolution 14-01-09. (A copy of the resolution is included in the minutes). Mr. Wilson addressed the concern regarding tools for the Road Department to carry in the trucks. Mr. Wilson stated that no tools are required at this time but they would like to purchase a tool box for the truck. Mr. VanDeGrift made a motion to purchase the tool box at an approximate cost of \$350.00. Mr. Sams seconded the motion. All voiced a "YEA" vote and the motion was passed. A discussion was held regarding that annual road project with the Warren County Engineer's Office. Mr. Wilson stated that he would submit Turtlecreek Union Road, Cook Road, and Audubon for resurfacing. Mr. Wilson stated that he would not submit any subdivision until 2015 due the fact that the roads must be repaired and crack seal prior to the submission of these roads for improvements. The Trustees requested that Mr. Wilson provide a plan and take down schedule for the roads in the township and that this schedule be reviewed monthly for additional repair needs. Mr. Wilson stated that an experiment with the slurry seal product is a prerequisite for the 2015 plans for the roads. Mr. Wilson will price the cost of slurry seal for New England Way, Oak Ridge, and Turtlecreek Subdivision for 2014. Mr. Wilson stated that Turtlecreek Subdivision will be repaired and planned to resurface in 2015 per plan amended by Mr. Wilson and submitted to the Trustees. A list of the plan take down schedule for the township's roads will be attached to these minutes.
