The regular scheduled meeting of the Board of Trustees of Turtlecreek Township was held on September 29, 2015 at 8:00 a.m. with the following person present:

The meeting opened with Mr. Sams leading the Pledge of Allegiance.

The minutes of the previous meeting were received by the Trustees prior to the meeting for review. Since there were no additions or corrections, Mr. Jones moved for acceptance, seconded by Mr. VanDeGrift. All were in favor and the minutes were approved as written.

A resident on Miller Road requested that the speed limit be reduced. Mr. Jones made a motion for a speed study to be completed to see if the speed limit needs to be reduced. Mr. VanDeGrift seconded the motion. All voiced a "YEA" vote and the motion was passed with **Resolution 15-09-05**. (A copy of the resolution is included in the minutes).

The Fiscal Officer notified the Trustees that a Notice to Proceed for the Liberty Keuter Pier Wall Project has been issued.

Department Reports:

Fire/EMS: Mike Jameson, Assistant Fire Chief reported fire and EMS incident information. Assistant Chief Jameson reported that the generator for the administrative building is having issues and will need to be repaired at a cost of \$3,362.90. Buckeye Power Sales is the only business locally that can make the repairs. Mr. VanDeGrift made a motion to repair the generator. Mr. Jones seconded the motion. All voiced a "YEA" vote and the motion was passed. Lt. Campbell presented the Trustees with the information that the LifePaks 15 need to be serviced. The cost to service all three units for three (3) years is \$1,454.33 per year per unit. Total cost will be \$13,089.00. Mr. Jones made a motion to renew the service contract at a cost of \$13,089.00. Mr. VanDeGrift seconded the motion. All voiced a "YEA" vote and the motion was passed with **Resolution 15-09-04.** (A copy of the resolution is included in the minutes).

Road and Bridge: Ron Chasteen, Road Supervisor, presented his weekly department activity reports completed since the previous meeting. Mr. Chasteen reported that the repair to asphalt in the Trails of Shaker Run has been completed. The Trustees made a motion to accept Shaker Run Section One Phases F & G in the last meeting. A letter will be sent to the WC Engineer's office that these sections are accepted for public maintenance. Mr. Chasteen reported that the Liberty Keuter Pier Wall Project should be completed within the next week. A discussion was held regarding the repair of the 95 dump truck. Assistant Chief Jameson stated that he believes that the gas tanks need to be repaired or replaced. The discussion is continued until the next meeting.

RESOLUTION 15-09-05 TURTLECREEK TOWNSHP WARREN COUNTY, OHIO

A RESOLUTION REQUESTING THE DIRECTOR OF TRANSPORTATIONS TO ESTABLISH A REASONABLE AND SAFE SPEED LIMIT ON MILLER ROAD

WHEREAS, a request has been made to this Board of Trustees that the statutory vehicular speed limit established by Ohio Revised Code, Sec. 4511.21 is greater than that considered reasonable and safe on Miller Road and,

WHEREAS, the Warren County Engineer has performed an engineering and traffic investigation upon the section of road described, and;

WHEREAS, it is the belief of this Board that such investigation confirms the allegation that the statutory speed limit of 45mph is unrealistic,

NOW THEREFORE, BE IT RESOLVED, by the Board of Trustees, Turtlecreek Township that:

Section 1. By virtue of the provisions of Ohio Revised Code, Sec. 4511.21, the Director of Transportation is hereby requested to review the engineering and traffic investigation prepared by the Warren County Engineer and to determine and declare a reasonable and safe prima facie speed limit on Miller Road and ;

Section 2. That when the Board is advised that the Director of Highways has determined and declared a reasonable and safe speed limit on the section of road described in Section 1 hereof, standard signs, properly posted and giving notices thereof, will be erected.

Mr. Jones moved to adopt the foregoing Resolution. Mr. VanDeGrift seconded the motion. All voiced a "YEA" vote and the Resolution was passed.
