The regular scheduled meeting of the Board of Trustees of Turtlecreek Township was held on November 9, 2015 at 7:00 p.m. with the following person present:

The meeting opened with Mr. Jones leading the Pledge of Allegiance.

The minutes of the previous meeting were received by the Trustees prior to the meeting for review. Since there were no additions or corrections, Mr. VanDeGrift moved for acceptance, seconded by Mr. Jones. All were in favor and the minutes were approved as written.

The Fiscal Officer notified the Trustees that the financial reports for the previous month were available for their review. By motion of Mr. VanDeGrift and seconded by Mr. Jones the following reports were approved. Cash Summary by Fund (month to date and year to date), Fund Status Report, and Bank Reconciliation for the previous month.

The Trustees discussed the rezoning on the Cunningham property. The Trustees requested a letter be sent to Warren County Zoning stating that the Trustees would like to see a more detailed plan regarding this property rezoning.

Warren County Regional Planning Commission presented the Trustees with the 223 Firearms Outfitter plan. At this time the Trustees decline to comment.

Ms. Boggs presented the request from Warren County Port Authority for the contribution to the Small Business Development Center for \$500.00.
