The regular scheduled meeting of the Board of Trustees of Turtlecreek Township was held on May 30, 2017 at 8:00 a.m. with the following person present:

The meeting opened with Mr. Jones leading the Pledge of Allegiance.

The minutes of the previous meeting were received by the Trustees prior to the meeting for review. Since there were no additions or corrections, Mr. Sams moved for acceptance, seconded by Mr. VanDeGrift. All were in favor and the minutes were approved as written.

Administration:

Tammy Boggs, Township Administrator, informed the board that the Township's maintenance technician was requesting funds to purchase a new tool box and additional tools for the township service bay. Mr. VanDeGrift made a motion, seconded by Mr. Sams to approve for the purchase of up to \$1,100.00 for a toolbox and tools for the service bay. All present voiced a "YEA" vote and the motion passed with resolution **17-05-13** (a copy of the resolution will be included in the minutes).

Mrs. Boggs informed the board of a letter received from Mr. Macy regarding Chief Flint and his outstanding involvement with the Township. The Trustees each thanked Chief Flint for his service and dedication to the Township.

Mrs. Boggs informed the board that an emergency repair was made to M34 at a cost of \$1,500.00. Mr. Sams made a motion, seconded by Mr. VanDeGrift to approve the repair of the squad. All present voiced a "YEA" vote and the motion passed with resolution **17-05-12** (a copy of the resolution will be included in the minutes).

Mrs. Boggs informed the board she had discussed the issue regarding the culvert at the Greentree and Union Road intersection and that the County Engineer was aware and involved in a matter with the bank regarding the project.

Mrs. Boggs asked if the board would like to make a \$500.00 donation to the Warren County Junior Fair Board for trophies. A discussion was held regarding uses of the donation and its benefit to the taxpayers. Mr. Sams made a motion, seconded by Mr. Jones to approve for the donation to the Warren County Junior Fair Board in the amount of \$500.00. All present voiced a "YEA" vote and the motion passed with resolution **17-05-11** (a copy of the resolution will be included in the minutes).

Mrs. Boggs informed the board that a review had been done regarding the training request for the year for firefighters and EMT's. A request was made for up to \$20,000.00 in funds approved for use to cover these trainings including paramedic, instructor, and a work study. Mr. VanDeGrift made a motion, seconded by Mr. Sams to approve the \$20,000.00 request for training. All present voiced a "YEA" vote and the motion passed with resolution **17-05-15** (a copy of the resolution will be included in the minutes).

Mrs. Boggs presented the board with additional revisions to the logo for Township branding. The board decided to request additional alterations to the submitted designs. Mr. Johnson informed the board we had approved the expenditure a while back and that he would be paying Mrs. Guerra for her work on the logos.

Mrs. Boggs informed the board that Townships have the ability to pass resolutions restricting marijuana grow operations in the Township. Mr. VanDeGrift made a motion, seconded by Mr. Jones to prohibit marijuana grow operations in the Township. All present voiced a "YEA" vote and

the motion passed with resolution **17-05-10** (a copy of the resolution will be included in the minutes).

Fiscal Officer Reports:

Mr. Johnson informed the board that due to unplanned repairs this year, most of the appropriations set for the 2192 repairs fund had been encumbered already and requested a line item transfer of \$50,000.00 from 2192-220-599-0000 (Other Expenses) to 2192-220-323-0000 (Repairs and Maintenance). Mr. Sams made a motion, seconded by Mr. VanDeGrift to approve the line item transfer. All present voiced a "YEA" vote and the motion passed with resolution **17-05-16** (a copy of the resolution will be included in the minutes).

Mr. Johnson also informed the board that he would need additional approval for legal fees for Bricker and Eckler in the amount of \$60,000.00 for the Union Village TIF project. Mr. VanDeGrift made a motion, seconded by Mr. Sams to approve the payment of the legal fees. All present voiced a "YEA" vote and the motion passed with resolution **17-05-17** (a copy of the resolution will be included in the minutes).

TOPIC OF RESOLUTION: PROHIBTING MEDICAL MARIJUANA CULTIVATORS, PROCESSORS AND RETAIL DISPENSARIES LICENSED UNDER CHAPTER 3796 OF THE OHIO REVISED CODE [MEDICAL MARIJUANA CONTROL PROGRAM] IN THE UNINCORPORATED TERRITORY OF TURTLECREEK TOWNSHIP, WARREN COUNTY, OHIO

WHEREAS, House Bill 523, effective September 8, 2016, is the state enabling legislation wherein the Ohio Legislature delegated authority to townships to regulate medical marijuana facilities, including without limitation, that a board of township trustees pursuant to Section 3796.29 of the Ohio Revised Code may adopt a resolution to prohibit, or limit the number of, cultivators, processors, or retail dispensaries licensed under this chapter within the unincorporated territory of the township; and,

WHEREAS, this Board deems it is in the interest of public health, safety, and general welfare of Turtlecreek Township to prohibit the cultivation, processing and retail dispensing of medical marijuana in the unincorporated territory of Turtlecreek Township.

THEREFORE, BE IT RESOLVED by the Board of Trustees of Turtlecreek Township, Warren County, Ohio, at least a majority of all Trustees casting a vote concur as follows:

Section 1. That the Board does prohibit cultivators, processors, or retail dispensaries licensed under Chapter 3796 of the Ohio Revised Code [Medical Marijuana Control Program] within the unincorporated territory of Turtlecreek Township, Warren County, Ohio.

Section 2. This Resolution does not limit research related to marijuana conducted at a state university, academic medical center, or private research and development organization as part of a research protocol approved by an institutional review board or equivalent entity.

Section 3. That the Board is acting in its legislative capacity in adopting this Resolution.

Section 4. That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.

Section 5. That it is found and determined that all formal actions of the Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of the Board in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Mr. VanDeGrift moved adoption of the foregoing Resolution, being seconded by Mr. Sams. Upon call of the roll, the following vote resulted:
