The regular scheduled meeting of the Board of Trustees of Turtlecreek Township was held on January 30, 2018 at 8:00 a.m. with the following persons present:

TRUSTEES: Jim VanDeGrift, Dan Jones, and Jonathan Sams FISCAL OFFICER: Amanda Childers GUEST: Steve Flint, Tammy Boggs, Neil Tunison, Ron Chasteen, Mike Jameson and Roger Wainscott.

The meeting opened with Mr. Sams leading the Pledge of Allegiance.

Copies of the minutes from the January 8, 2018 meeting were given to the board for review prior to the meeting. Mr. Jones made a motion, seconded by Mr. VanDeGrift to accept the minutes as written. All present voiced a "YEA" vote and the motion passed.

Department Reports:

Fire/EMS:

Steve Flint, Fire Chief, informed the board that the Bureau of Workers Comp grant money was received in the amount of \$7,333.33. Our match of \$1,466.67 will be added and used to purchase hoods and gloves for the fire department totaling \$8,800.00.

Mr. Flint informed the board that we have received insurance claim money for the radio stolen out of a Township Truck in the amount of \$3,500.00. The actual replacement cost is \$4,372.18, so an additional amount of \$872.18 will need to be provided by the Township. Mr. Jones made a motion to approve the purchase of the replacement radio using the \$3,500.00 insurance claim funds and \$872.18 in township funds, seconded by Mr. VanDeGrift. All voiced a "YEA" vote and the motion was passed with **Resolution 18-01-07.** (A copy of the resolution is included in the minutes).

Chief Flint informed the board that a garage door at EMS/Fire Station 32 is in need of repairs in the amount of \$1,600.00. Mr. VanDeGrift made a motion for the payment of repairs for the garage door at Station 32 in the amount of \$1,600.00, seconded by Mr. Jones. All voiced a "YEA" vote and the motion was passed with **Resolution 18-01-10.** (A copy of the resolution is included in the minutes).

Mike Jameson, Assistant Fire Chief, informed the board that Medic 33 needs replacement of three injectors for a cost of \$1,178.55. The injectors have been received and will be installed shortly. Engine 32 injectors are being tested now. Mrs. Boggs approved the payment.

Mr. Jameson, requested authorization to purchase the fourth Toughbook for EMS Operations in the amount of \$4,096.25. Mr. VanDeGrift made a motion to approve the purchase of the Toughbook for \$4,096.25, seconded by Mr. Jones. All voiced a "YEA" vote and the motion was passed with **Resolution 18-01-08.** (A copy of the resolution is included in the minutes).

Mr. Neil Tunison, Warren County Engineer, requested the board to make an amendment to an agreement between Turtlecreek Township Trustees and the Board of Union Township Trustees. The original agreement, "The Turtlecreek-Union Road and Wood Road Improvement Project", needs to be changed to substitute Wood Road with Phillips Road. Changing the agreement will allow OPWC to complete funding for the road improvements, which are nearly complete. The original project had been changed to Phillips road instead of Wood Road early in the process but the project manager neglected to make the change on the agreement. Mr. VanDeGrift made a motion to allow for Mr. Jonathan D. Sams, President of the Board of Turtlecreek Township, to sign the amended cooperative agreement for the project to OPWC so that payment from the Loan CJU92 may be released to the contractor. Mr. Jones seconded the motion, all voiced a "YEA" vote and the motion was passed with **Resolution 18-01-06.** (A copy of the resolution is included in the minutes.

Mr. Jones asked Mr. Tunison about updating road construction standards. Mr. Tunison noted that the equipment used in home construction is much heavier now than in the past. The Engineers Office is in the process of gathering data to determine how to update the road construction specs. Once the standards are finalized, he will submit them to the Townships and the Warren County Commissioners.

Road and Bridge:

Ron Chasteen, Road Supervisor, informed the board his department has been working on potholes. Pavement must be obtained in two-ton minimum batches, so they prepare the small potholes on one day and fill them the next. Larger potholes must be prepared and filled the same day. Additionally, he is reviewing roads for asphalt replacement.

Mrs. Boggs, Township Administrator, informed the board that we have received the request to approve Estates of Keever Creek Section 1A Phase 1A and Phase 2A. Mr. Chasteen agreed we are ready to accept it because the Developer has agreed to make repairs in the future that are caused from new construction. A letter will be sent to the Warren County Engineers Office of the Township's acceptance. Mr. VanDeGrift made a motion to accept Estates of Keever Creek Section 1A Phase 1A and Phase 2A, Mr. Jones seconded the motion. All voiced a "YEA" vote and the motion passed.

Administration:

Mrs. Boggs requested authorization to engage the legal service of Frost, Brown, and Todd for the Economic Development of Land within Turtlecreek Township. Mrs. Boggs requested a Purchase Order for \$10,000.00 from which to pay their fees. Mr. VanDeGrift made a motion to approve the engagement of Frost, Brown and Todd for legal services for economic development of land, Mr. Jones seconded the motion. All voiced a "YEA" vote and the motion passed with **Resolution 18-01-09.** (A copy of the resolution is included in the minutes).

Mrs. Boggs informed the Board that Regional Planning Representatives are needed for Reappointment due to one person leaving. The group meets quarterly and two township residents are needed at each meeting. Mrs. Boggs and Mr. Shaffer are usually in attendance, and the current alternate, Gabe Drake has been asked to fill the vacancy. So at least one alternate is needed to be identified to join the meetings. The Trustees agreed to find persons they think may be interested in becoming involved with Regional Planning issues.

Mrs. Boggs asked that the minutes reflect that Mr. Sams will sign the renewal application for Public Entity Insurance. One the application is turned in they will come back with a rate and she will bring that before the board.

Mrs. Boggs informed the board of a proposal for survey of the park land. The cost is in the amount of \$2,850.00 to Evans CivilPro Engineers, LLC. Mr. VanDeGrift made a motion to approve the payment of \$2,850.00 to Evans CivilPro Engineers, LLC. Mr. Jones seconded the motion. All voiced a "YEA" vote and the motion passed with **Resolution 18-01-11.** (A copy of the resolution is included in the minutes).

Mrs. Boggs informed the board that an invoice for payment of legal services for the Lebanon Turtlecreek JEDD Board from Bricker and Eckler was received in the amount of \$1,191.60. Mr. Jones made a motion, seconded by Mr. VanDeGrift to pay the legal fees of \$1,191.60 out of the General Fund. All present voiced a "YEA" vote and the motion passed with **Resolution 18-01-12.** (A copy of the resolution is included in the minutes).

Mr. Jones moved to approve the engagement for legal services of Bricker and Eckler for economic development of land for \$1,000.00. Mr. VanDeGrift seconded the motion. All voiced a "YEA" vote and the motion passed with **Resolution 18-01-13.** (A copy of the resolution is included in the minutes).

Mrs. Childers, Fiscal Officer, informed the board she would be attending the Ohio Township Association conference in Columbus. She will be advancing personal funds for hotel, meals and mileage during the conference and will present them at the next meeting. Mr. VanDeGrift made a motion to approve the Fiscal Officer's attendance at the conference and the expected expenses to be presented at the next meeting. Mr. Jones seconded the motion. All voiced a "YEA" vote and the motion passed.

A RESOLUTION AUTHORIZING TURTLECREEK TOWNSHIP TO AMEND THE TURTLECREEK-UNION ROAD AND WOOD ROAD IMPROVEMENT PROJECT BY SUBSTITUTING PHILLIPS ROAD FOR WOOD ROAD CHANGING THE PROJECT NAME TO TURTLECREEK-UNION ROAD AND PHILLIPS ROAD IMPROVEMENT PROJECT

WHEREAS, the State Capital Improvement Program and the Local Transportation Improvement Program both provide financial assistance to political subdivisions for capital improvements to public infrastructure, and

WHEREAS, the Board of Union Township Trustees Board entered into a cooperative agreement with Turtlecreek Township Trustees in planning to make capital improvements to Turtlecreek-Union Road and Wood Road, and

WHEREAS, the Board of Union Township Trustees initially planned to improve Phillips Road before Wood Road, and the estimate of cost of improvements to Phillips Road is slightly less than those to Wood Road, and

WHEREAS, the Project Manager assembled a bid package that included Phillips Road in place of Wood Road without amending the project agreement and that work is on the project is substantially complete, and

WHEREAS, the Board of Turtlecreek Township Trustees agrees to amend the cost allocation to each township to reflect the cost of work in Union Township and Turtlecreek Township,

WHEREAS, an amended cooperative agreement is requested to reflect the changes to the project approved for funding by OPWC having been approved by the Board of Trustees of Union Township and Turtlecreek Township, and

WHEREAS, the infrastructure improvement herein above described is considered to be a priority need for the community and is a qualified project under the OPWC programs,

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of Turtlecreek Township, Warren County, the President of the Board of Trustees of Turtlecreek Township, Jonathan D. Sams, is hereby authorized to sign amended cooperative agreement for the project to OPWC so that payment from the Loan CJU92 may be released to the contractor.
