The regular scheduled meeting of the Board of Trustees of Turtlecreek Township was held on May 14, 2018 at 7:00 p.m. with the following person present:

TRUSTEES: Daniel Jones and Jim VanDeGrift (Jonathan Sams was absent) CHIEF FISCAL OFFICER: Amanda Childers GUESTS: Steve Flint, Tammy Boggs, Ron Chasteen and Gene Bustle.

The meeting opened with Mr. VanDeGrift leading the Pledge of Allegiance.

The minutes of the previous meeting, April 24, 2018 were received by the Trustees prior to the meeting for review. Since there were no additions or corrections, Mr. Jones moved for acceptance, seconded by Mr. VanDeGrift. All were in favor and the minutes were approved as written.

The Fiscal Officer notified the Trustees that the financial reports for the previous month were available for their review. By motion of Mr. Jones and seconded by Mr. VanDeGrift the following reports were approved: Cash Summary by Fund (month to date and year to date), Fund Status Report, and Bank Reconciliation for the previous month.

Gene Bustle was present, representing the Fort Ancient Restored Machinery Club. He invited the Trustees and all present to participate in The Great Warren County Tractor Ride also known as Tractor Trek. It will occur on Saturday June 16, 2018. Mr. Bustle thanked the trustees for their past sponsorship and requested continued support. Mr. Bustle noted that the purpose of the event is to raise funds for various Warren County needs. Mr. Jones made a motion, seconded by Mr. VanDeGrift to make a \$400.00 donation for the event. All were in favor and the motion was passed with Resolution **18-05-02** (a copy of the resolution will be included in the minutes).

Department Reports:

Fire/EMS:

Steve Flint, Fire Chief, informed the board that Engine 32 needs repairs in the amount of \$6,844.55 for replacement of the high-pressure fuel pump. Mr. Jones made a motion, seconded by Mr. VanDeGrift to approve the repair for Engine 32 in the amount of \$6,844.55. All present voiced a "YEA" vote and the motion was passed with Resolution **18-05-01** (a copy of the resolution will be included in the minutes).

Road and Bridge:

Ron Chasteen, Road Supervisor, informed the board his staff has been mowing along the roads as well as accomplishing dirt work, seeding and ditching in various locations.

Mr. Chasteen along with Mrs. Boggs informed the board that the ditches in the Estates of Keever Creek will most likely remain wet to some degree. This is because the houses have sump pumps, curtain drains and downspouts emptying into the ditches. Mrs. Boggs will send a letter to resident spokesperson Mr. Murphy detailing their findings. The letter will state that the Township will fill in some low spots in the ditches and eroded soil in the right of way but anything beyond that is not the Township's responsibility. Additionally, she asks that he forward the letter to the homeowner's association and other residents.

Administration:

Mrs. Tammy Boggs, Township Administrator, requested an additional Purchase Order for legal services for Frost Brown Todd for CRA & JEDD for the economic development of State Prison land in the amount of \$10,000.00 from which to pay their fees. Mr. Jones made a motion, seconded by Mr. VanDeGrift to approve the Purchase Order to Frost Brown Todd in the amount of \$10,000.00. All present voiced a "YEA" vote and the motion was passed with Resolution **18-05-03** (a copy of the resolution will be included in the minutes).

Mrs. Boggs asked the trustees for approval for Penny Haas to teach an EMS class at Station 32. Mrs. Haas normally teaches the class at the Warren County Career Center, but that class is not being offered at this time. Two Township Employees would like to take the class, so consideration is requested to decide if this can be done at the Township. Mrs. Boggs will speak with our Human Resource Advisors for direction as to how and if this can be done with Mrs. Haas as an outside instructor during her scheduled hours.

Mrs. Boggs informed the trustees that additional roof repairs are needed at Station 32 in the amount of \$3,150.00. Mid Miami Roofing found issues when they were making other repairs. Mr. Jones made a motion seconded by Mr. VanDeGrift to approve the roof repairs and payment to Mid Miami Roofing in the amount of \$3,150.00. All present voiced a "YEA" vote and the motion was passed.

Mrs. Boggs informed the trustees that she applied for the OKI grant for LED lighting for Station 31 and parking lights at station 32. The grant is offered as part of the Community Energy Plan through OKI and the grant was approved. Mrs. Boggs will get more information and details as to the amount and if matching funds are required. Mr. VanDeGrift requested electric cost comparisons for Station 32 before and after LED lighting was installed within the building.

Mrs. Boggs informed the trustees that the Regional Planning Commission was requesting input on Taylor's Ridge preliminary plan of seven lots on Old Hamilton Rd. The Trustees responded with no objection regarding the preliminary plan.

Mrs. Boggs informed the trustees that the Regional Planning Commission was requesting input on Shaker Run Section Five Phase C Final Plat and asked if the Trustees have any comments or concerns. The Trustees responded with no objection regarding the plat.
