The regular scheduled meeting of the Board of Trustees of Turtlecreek Township was held on June 11, 2018 at 7:00 p.m. with the following person present:

TRUSTEES: Daniel Jones and Jim VanDeGrift (Jonathan Sams was absent)

CHIEF FISCAL OFFICER: Amanda Childers

GUESTS: Steve Flint, Tammy Boggs, Mike Jameson, Ron Chasteen and Mike Shaffer.

The meeting opened with Mr. Jones leading the Pledge of Allegiance.

The minutes of the meeting dated May 14, 2018 were received by the Trustees prior to the meeting for review. Since there were no additions or corrections, Mr. Jones moved for acceptance, seconded by Mr. VanDeGrift. All were in favor and the minutes were approved as written.

The Fiscal Officer notified the Trustees that the financial reports for the previous month were available for their review. By motion of Mr. Jones and seconded by Mr. VanDeGrift the following reports were approved: Cash Summary by Fund (month to date and year to date), Fund Status Report, and Bank Reconciliation for the previous month.

Road and Bridge:

Ron Chasteen, Road Supervisor, informed the board his staff has been mowing along the roads as well as accomplishing dirt work, seeding and ditching in various locations.

Mr. Chasteen informed the board that he would like the Township to accept the roads in Shaker Run Section Four Phase A. Mr. Jones made a motion, seconded by Mr. VanDeGrift to accept the roads in Shaker Run Section Four Phase A. All present voiced a "YEA" vote and the motion passed.

Mr. Chasteen informed the board that his department has been busy fixing catch basins, grading, applying crack sealant, fixing damage from snowplows as well as filling potholes with asphalt.

Administration:

Mrs. Tammy Boggs, Township Administrator, informed the board that Mitch Conway has completed his six-month probationary period, as a full time paramedic would need a pay increase effective 5-12-2018 of \$1.00 per hour. Mr. Jones made a motion, seconded by Mr. VanDeGrift to approve the pay increase of Mitch Conway for \$1.00 per hour effective 5-12-2018. All present voiced a "YEA" vote and the motion passed with resolution 18-06-01 (a copy of the resolution will be included in the minutes).

Mrs. Boggs informed the board that Matthew Helton has completed his six-month probationary period, as a full time paramedic would need a pay increase effective 5-26-2018 of \$.25 per hour. Mr. Jones made a motion, seconded by Mr. VanDeGrift to approve the pay increase of Matthew Helton for \$.25 per hour effective 5-26-2018. All present voiced a "YEA" vote and the motion passed with resolution 18-06-02 (a copy of the resolution will be included in the minutes).

Mrs. Boggs received a notice from Warren County Rural Zoning Inspection of a conditional use/site plan review for property located at 1382 Union Road. The owners have applied to operate a Class 2 Home Occupation to operate a clock repair business in an existing accessory building.
