The regular scheduled meeting of the Board of Trustees of Turtlecreek Township was held on December 9, 2019 at 7:00 p.m. with the following persons present:

TRUSTEES: Jim VanDeGrift, Dan Jones and Jonathan Sams.

FISCAL OFFICER: Amanda Childers

GUEST: Steve Flint, Ron Chasteen, Ryan Cook and Stan Williams.

The meeting opened with Mr. VanDeGrift leading the Pledge of Allegiance.

The minutes of the meeting held on November 26, 2019 were received by the Trustees prior to the meeting for review. Since there were no additions or corrections, Mr. Jones moved for acceptance, seconded by Mr. VanDeGrift. All were in favor and the minutes were approved as written.

The Fiscal Officer notified the Trustees that the financial reports for the previous month were available for their review. By motion of Mr. Sams and seconded by Mr. Jones the following reports were approved. Cash Summary by Fund (month to date and year to date), Fund Status Report, and Bank Reconciliation for the previous month.

Stan Williams and Ryan Cook presented the Eastern Turtlecreek Plan to the Board. Both gentlemen are from Warren County Regional Planning and coordinated the development of the plan along with input from residents, stakeholders and interested parties. Once the Township Board reviews and recommends the plan, it will go to Regional Planning for a full committee recommendation. After that it will be presented to the Board of Commissioners for adoption to update the Warren County Comprehensive Plan. The Trustees agreed to do a final review and send a letter of approval to Warren County Regional Planning.

Mr. Jones administered the Oath of Office to Mr. VanDeGrift.

Mr. VanDeGrift said it was time to elect officers for next year. Mr. Sams made a motion, seconded by Mr. Jones to appoint Trustee Dan Jones as Chairman of the Board for 2020. All present voiced a "YEA" vote and the motion passed. Mr. VanDeGrift followed with a motion, seconded by Mr. Jones to appoint Trustee Jonathan Sams as Vice President of the board of the board for 2020. All present voiced a "YEA" vote and the motion passed.

Amanda Childers, Fiscal Officer, reminded the Board that the final meeting for the month of December will be on the 20th at 8:30 a.m.

Department Reports:

Fire/EMS:

Steve Flint, Fire Chief, informed the Board that they needed to make appointments to the Volunteer Fire Fighters Dependents Fund for the 2020 year. The current appointees are Dan Jones, Jim VanDeGrift, Jon Campbell, Brent Wright, Frank Tone and Jon Paul Campbell. Mr. Sams made a motion seconded by Mr. Jones to appoint the same individuals as listed above. All voiced a "YEA" vote and the motion was passed.

Chief Flint, informed the trustees that Sean Connelly has completed his six month probationary period and is due a pay raise bringing his hourly rate to \$19.57. Mr. Jones made a motion to approve the increase in pay for Mr. Connelly to \$19.57 beginning December 7, 2019. Mr. Sams seconded the motion. All voiced a "YEA" vote and the motion was passed with **Resolution 19-12-23**. (A copy of the resolution is included in the minutes).

Road and Bridge:

Ron Chasteen, Road and Bridge Supervisor, gave an update on his departments activities. He stated that the snow plows are ready for winter weather and a cemetery base was repaired. Additionally, blacktop repairs were made in the Trails of Shaker Run and a tree fell and was removed from Nickel Road.

Administration:

Mrs. Childers (on behalf of Tammy Boggs, Administrator) asked the Trustees if they wanted to donate to the Lebanon Food Pantry. Mr. VanDeGrift made a motion, seconded by Mr. Jones to approve a donation to the Lebanon Food Pantry in the amount of \$500.00. All Present voiced a

"YEA" vote and the motion passed with **Resolution 19-12-20** (A copy of the resolution will be included in the minutes.)

Mrs. Childers presented the Temporary Appropriations as well as the Year End Resolutions to the Trustees.
