#### **TURTLECREEK TOWNSHIP BOARD OF TRUSTEES**

ON DECEMBER 10 18

The regular scheduled meeting of the Board of Trustees of Turtlecreek Township was held on December 10, 2018 at 7:00 p.m. with the following persons present:

TRUSTEES: Jim VanDeGrift and Daniel Jones (Jonathan Sams was absent)

FISCAL OFFICER: Amanda Childers

GUEST: Tammy Boggs, Steve Flint, Mike Jameson and Ron Chasteen.

The meeting opened with Mr. VanDeGrift leading the Pledge of Allegiance.

Prior to the meeting, the Audit/Financial Committee met to review the financial reports for the year to date. The Committee indicated that a line item transfer in the Fund 2193 is needed for salaries. The semi-annual audit committee reviewed the year to date reports. The committee noted that at this time there is no need for transfers, additional line items, revenue revisions or amended appropriations. Mr. Jones moved for acceptance, seconded by Mr. VanDeGrift. All were in favor and the financials were approved as written.

Mrs. Boggs requested a line item transfer of \$90,000.00 from 2193-930-930-0000 (Contingencies) to 2193-230-190-0000 (Salaries) for needed expenses. Mr. Jones made a motion, seconded by Mr. VanDeGrift to approve the line item transfer. All present voiced a "YEA" vote and the motion passed with **Resolution 18-12-22** (a copy of the resolution will be included in the minutes.)

The minutes of the meeting held on November 27, 2018 were received by the Trustees prior to the meeting for review. Since there were no additions or corrections, Mr. Jones moved for acceptance, seconded by Mr. VanDeGrift. All were in favor and the minutes were approved as written

The Fiscal Officer, notified the Trustees that the financial reports for the previous month were available for their review. By motion of Mr. Jones and seconded by Mr. VanDeGrift the following reports were approved. Cash Summary by Fund (month to date and year to date), Fund Status Report, and Bank Reconciliation for the previous month.

Tammy Boggs, Township Administrator, presented the Temporary Appropriations as well as the Year End Resolutions to the Trustees. She noted the rate for travel expense reimbursement is now .545 cents per mile. Also, a new resolution authorizing the Fiscal Officer to pay all bills for the township that come due between meeting dates. The payment of the bills will be ratified at the next regular Trustees meeting with the approval of vouchers, electronic warrants and warrants. Mr. Jones made a motion to approve the Temporary Appropriations and Year End Resolutions. Mr. VanDeGrift seconded the motion. All voiced a "YEA" vote and the motion was passed with **Resolutions 18-12-01 – 18-12-18.** (Copies of the resolutions are included in the minutes.)

# Fire/EMS:

## Road and Bridge:

Ron Chasteen, Road and Bridge Supervisor informed the Board that the invoice from Barrett for blacktop work came in at \$257,887.00. The estimate was \$285,000.00, so this was great news. Mr. VanDeGrift asked Mr. Chasteen if he was happy with the completed work. Mr. Chasteen said he was except for one area in Buckeye Fields Subdivision that will be repaired in the spring once warm weather returns.

Mr. Chasteen informed the Board that his department has used 100 tons of salt to date. He ordered 900 tons at \$54.00 per ton. By comparison, they used 683 tons last winter.

Tammy Boggs, Township Administrator, requested authorization to sign the work contract agreement for Buckeye Fields. Mr. VanDeGrift made a motion, seconded by Mr. Jones to approve Mrs. Boggs authorization to sign the work contract agreement for Buckeye Fields. All present voiced a "YEA" vote and the motion passed.

#### Administration:

Mr. Jones made a motion for appointments to the Volunteer Fire Fighters Dependents Fund for the 2019 year. Mr. VanDeGrift seconded the motion. All voiced a "YEA" vote and the motion was

passed. The appointments are Mr. Daniel Jones, Mr. Jim VanDeGrift, Mr. Jon Campbell, Mr. Brent Wright, Mr. Frank Tone, and Mr. JonPaul Campbell as secretary.

Mrs. Boggs asked the Board if they had any comments or concerns regarding the text amendments for zoning. The amendments addressed wedding event facilities, stadiums, casinos, traffic circulation, setbacks, signage, lighting, and fire/ems egress. The Trustees had no concerns or comments. (A letter will be sent to Warren County Zoning stating this information).

Mrs. Boggs requested a resolution to authorize Mr. VanDeGrift to sign the Criteria Architect Contract with KZF Design for the new fire station 33. KZF will be engaged through completion of the project. Mr. Jones made a motion, seconded by Mr. VanDeGrift to authorize Mr. VanDeGrift, Vice-President, to sign the contract for KZF Design as the Criteria Architect for the completion of project for Station 33. All present voiced a "YEA" vote and the motion passed with **Resolution 18-12-19** (A copy of the resolution will be included in the minutes.)

Mrs. Boggs requested subsequent approval for expenditures authorized by Township Administrator or Township Officer or Employee authorized by Township Administrator in the cumulative amount of \$29.97. Mr. Jones made a motion, seconded by Mr. VanDeGrift to subsequently approve the expenditures in the cumulative amount of \$29.97.
