TURTLECREEK TOWNSHIP BOARD OF TRUSTEES

ON APRIL 28 20

The regular scheduled meeting of the Board of Trustees of Turtlecreek Township was held by teleconference on April 28, 2020 at 8:18 a.m. with the following persons:

TRUSTEES: Dan Jones, Jim VanDeGrift and Jonathan Sams FISCAL OFFICER: Amanda Childers GUEST: Tammy Boggs, Ron Chasteen, Mike Jameson, Brian Elleman, Mike Shaffer, and Brad Edington.

The meeting opened with Mr. Jones leading the Pledge of Allegiance.

The minutes of the meeting held on April 13, 2020 were received by the Trustees prior to the meeting for review. Since there were no additions or corrections, Mr. Sams moved for acceptance, seconded by Mr. VanDeGrift. All were in favor and the minutes were approved as written.

Department Reports:

Fire/EMS:

Mike Jameson, Fire Chief, was asked about the status of the stair climber by Mr. VanDeGrift. Chief Jameson said he recommends holding off on the purchase until later.

Chief Jameson informed the Board that EMS runs are down a bit, there have been several fire runs. The crews are working well with the change of having Station 31 staffed 24/7. Progress being made on the new Station 33.

Road and Bridge:

Mr. Chasteen informed the Board that his department will begin mowing rounds soon. Additionally, road pipes are being replaced on roads to be resurfaced including Nickel Rd and Liberty Keuter. Blacktop will be laid on top.

Administration:

Tammy Boggs, Township Administrator informed the Board that she received a letter from Warren County Regional Planning regarding the 3rd Addition Replat of Charleston Place. Comments are due to Regional Planning by May 8th. The Board had no comments or concerns. (A letter will be sent to Warren County Regional Planning stating this information).

Mrs. Boggs requested subsequent approval for expenditures authorized by Township Administrator or Township Officer or Employee authorized by Township Administrator in the cumulative amount of \$2236.80. The purchases include \$111.22 from Lowes, \$6.47 from Rural King, \$73.23 from Home Depot, \$347.64 from Amazon, \$1500.20 from Discount Drainage Supplies and \$195.04 from Swartz. Mr. VanDeGrift made a motion, seconded by Mr. Sams to subsequently approve the expenditures in the cumulative amount of \$2,236.80. All present voiced a "YEA" vote and the motion passed with **Resolution 20-04-08.** (A copy of the resolution will be included in the minutes).

Mrs. Boggs informed the board that three bids for special inspection services for the new Fire Station were received. The lowest bidder was Alt & Witzig Engineering at an approximate cost of \$16,100.00. Mr. VanDeGrift made a motion, seconded by Mr. Sams to approve special inspection services for Fire Station 33 for approximately \$16,100.00 by Alt & Witzig Engineering. All voiced a "YEA" vote and the motion was passed with **Resolution 20-04-09** (a copy of the resolution will be included in the minutes).

Mrs. Boggs presented vendor bids for retrofit of lighting for Station 31 and Station 32. The selected vendor is C.M. Mockbee Company in the amount of \$5,724.00 for Station 31 and \$9,085.00 for Station 32. The Board previously applied for a grant from OKI that will cover half the cost of the retrofits up to \$15,000.00. Additional rebates and incentives are available for this project in the amount of \$900.00. The total cost of the project less the rebates will be \$13,909.00 of which the Township will pay \$6,954.50. Mr. VanDeGrift made a motion, seconded by Mr. Sams to approve the lighting retrofit for Station 32 exterior lights and Station 31 interior and exterior lights, with Mrs. Boggs authorized to sign the contract with C.M. Mockbee Company. All voiced a "YEA" vote and the motion was passed with **Resolution 20-04-10** (a copy of the resolution will be included in the minutes).

Mrs. Boggs informed the Board that she received a request for permission to place a monument in the Turtlecreek Cemetery that is 84 inches in width. The rules for monuments carries a limit of 72 inches. The owner has eight cemetery lots. The Trustees will allow the oversize monument with the condition that they pay any additional costs for the supporting base. Mr. Sams made a motion, seconded by Mr. VanDeGrift to approve the monument of 84 inches in width. All voiced a "YEA" vote and the motion was passed.

Tammy Boggs, Township Administrator informed the Board that she received notice from Warren County Rural Zoning regarding a request for a zoning change to have a PUD with approximately 296-350 homes and townhomes on 141 acres on Butler Warren Road. This is not a retirement community. The expected pricing is 225,000 for the townhouses and 400,000 for the homes. Nothing has been received formally at this time.

RESOLUTION TO AUTHORIZE TAMMY BOGGS, ADMINISTRATOR TO SIGN PROPOSAL WITH C.M. MOCKBEE COMPANY. FOR LIGHTING RETROFIT FOR STATION 32 EXTERIOR LIGHTS AND STATION 31 INTERIOR/EXTERIOR LIGHTS

WHEREAS, the Turtlecreek Township Board of Trustees have received a proposal from C. M. Mockbee Company to retrofit all exterior lighting at Station 32 and interior/exterior at Station 31; and

WHEREAS, the Turtlecreek Township Board of Trustees have accepted the proposal from C. M. Mockbee Company in the amount of \$5,724.00 for Station 31 and \$9,085.00 for Station 32 and authorize Tammy Boggs, Administrator to sign the proposal; and

WHEREAS, the Turtlecreek Township Board of Trustees applied for a grant from OKI that will cover half the cost of the retrofits up to \$15,000.00; and

WHEREAS, there are also rebates/incentives available for this project in the amount of \$900.00. The total cost of the project less the rebates will be \$13,909.00.

WHEREAS, the Turtlecreek Township Board of Trustees will pay \$13,909.00 for both stations and will receive a payment from OKI in the amount of \$6,954.50 for the OKI grant half of the project. The source of the funds will be the General Fund (1000-120-323-000 – Repairs and Maintenance) in the amount of \$9,085.00 and Fire Fund (2192-220-323-0000 – Repairs and Maintenance) in the amount of \$4,824.00.

THEREFORE, by motion of Mr. VanDeGrift and seconded by Mr. Sams the above resolution was approved. All voiced a "YEA" vote and the resolution passed.
