The regular scheduled meeting of the Board of Trustees of Turtlecreek Township was held by teleconference on June 8, 2020 at 7:00 p.m. with the following persons:

The meeting opened with Mr. Jones leading the Pledge of Allegiance.

The minutes of the meeting held on May 26, 2020 were received by the Trustees prior to the meeting for review. Since there were no additions or corrections, Mr. VanDeGrift moved for acceptance, seconded by Mr. Jones. All were in favor and the minutes were approved as written.

Department Reports:

#### Fire/EMS:

Mike Jameson, Fire Chief, informed the Board that pump testing is needed from Finley Fire at a cost of \$875.00. Mr. VanDeGrift made a motion, seconded by Mr. Jones to approve the pump testing from Finley Fire at a cost of \$875.00. All present voiced a "YEA" vote and the motion was passed.

Chief Jameson informed the Board that Karen Haas has requested that she reduce her hours to twelve hours per week. Mr. VanDeGrift made a motion, seconded by Mr. Jones to approve the reduction in hours for Mrs. Haas to twelve hours per week. All present voiced a "YEA" vote and the motion was passed with **Resolution 20-06-01.** (A copy of the Resolution is included in the minutes.)

Chief Jameson informed the Board that Sean Connelly is due a pay increase as he has completed his probationary period. His pay will increase to \$20.16 per hour effective June 6, 2020. Mr. VanDeGrift made a motion, seconded by Mr. Jones to approve the pay increase for Mr. Connelly to \$20.16 effective June 6, 2020. All present voiced a "YEA" vote and the motion passed with **Resolution 20-06-02** (A copy of the resolution will be included in the minutes.)

Chief Jameson requested approval for installation of electric with Duke Energy for Fire Station 33 in the approximate amount of \$25,500.00; and to authorize Tammy Boggs Administrator to execute the documents. Mr. VanDeGrift made a motion, seconded by Mr. Jones to approve the foregoing resolution. All present voiced a "YEA" vote and the motion passed with **Resolution 20-06-04** (A copy of the resolution will be included in the minutes.)

Chief Jameson gave the Board a review of the accident that occurred on 350 where a tanker rolled over and spilled fuel. Hazmat was called in and our crews were there for most of the day.

# Road and Bridge:

Ron Chasteen, Road and Bridge Supervisor informed the Board that his department is on their second round of mowing. The grass is growing fast with all the rain we received.

Mr. Chasteen informed the Board that they moved a guard rail on Hollandsworth Road and have a bit more blacktop to repair there.

### Administration:

Tammy Boggs, Township Administrator, informed the Board that the OKI Grant was used to replace lighting at Stations 31 & 32 which has been completed. The remaining \$8,045.00 will be used on the new Station 33 lights.

Mrs. Boggs requested subsequent approval for expenditures authorized by Township Administrator, Township Officer, or Employee authorized by Township Administrator in the cumulative amount of \$40.28. The purchases are \$3.73 from Kroger and \$36.55 from Walmart. Mr. VanDeGrift made a motion, seconded by Mr. Jones to subsequently approve the expenditures in the cumulative amount of \$40.28.
