#### **TURTLECREEK TOWNSHIP BOARD OF TRUSTEES**

The regular scheduled meeting of the Board of Trustees of Turtlecreek Township was held by teleconference and in person on July 27, 2021 at 8:00 a.m. with the following persons:

TRUSTEES: Dan Jones, Jim VanDeGrift and Jonathan Sams.

FISCAL OFFICER: Amanda Childers

GUEST: Tammy Boggs, Mike Jameson (8:25 a.m., Brian Elleman, Dave Siebert, Brad Edrington

(phone), Connor Fulkerson and Leah Fulkerson.

The meeting opened with Mr. Sams leading the Pledge of Allegiance.

The minutes of the meeting held on July 12, 2021 were received by the Trustees prior to the meeting for review. Since there were no additions or corrections, Mr. VanDeGrift moved for acceptance, seconded by Mr. Jones. All were in favor and the minutes were approved as written.

Department Reports:

### Fire/EMS:

Brian Elleman, Assistant Fire Chief, informed the Board that a position for a Part-Time Paramedic/FF2 has been posted and both he and the Fire Chief have recommended Trent Estes to fill the position effective July 29, 2021, at the rate of \$19.00 per hour. Mr. VanDeGrift made a motion, seconded by Mr. Jones to approve hiring Trent Estes for Part-Time Paramedic/FF2 effective July 29, 2021, at the rate of \$19.00 per hour. All voiced a "YEA" vote and the motion was passed. **Resolution 21-07-04.** (A copy of the resolution will be included in the minutes.)

Assistant Chief Elleman informed the Board that a position for a Part-Time EMT/FF2 has been posted and both he and the Fire Chief have recommended Matthew Traver to fill the position effective August 9, 2021, at the rate of \$17.00 per hour. Mr. Jones made a motion, seconded by Mr. VanDeGrift to approve hiring Matthew Traver for Part-Time EMT/FF2 effective August 9, 2021, at the rate of \$17.00 per hour. All voiced a "YEA" vote and the motion was passed. **Resolution 21-07-05.** (A copy of the resolution will be included in the minutes.)

Assistant Chief Elleman requested a Resolution to purchase four sets of turnout gear at the approximate cost of \$10,206.00 from Fire Safety Services Inc. Mr. Jones made a motion, seconded by Mr. VanDeGrift to approve the purchase of turnout gear at a cost of \$10,206.00 from Fire Safety Services Inc. All voiced a "YEA" vote and the motion was passed. **Resolution 21-07-09.** (A copy of the resolution will be included in the minutes.)

Assistant Chief Elleman requested authorization to purchase twenty flashlights from Vogelpohl Equipment at a cost of \$1,040.20; twelve Nomex fire hoods at an approximate cost of \$977.28; two MSA Cairns 1044 helmets at a cost of \$491.52 from Vogelpohl and twelve Class 3 jackets at an approximate cost of \$628.76 from the Fire Store. Mr. VanDeGrift made a motion, seconded by Mr. Jones to approve the Resolution as stated above. All voiced a "YEA" vote and the motion was passed. **Resolution 21-07-10.** (A copy of the resolution will be included in the minutes.)

## Road and Bridge:

Dave Siebert, Road and Bridge Supervisor, informed the Board that the track hoe and trailer were ordered and should be received in October. The trade in value was too low so the old equipment will be sold on GovDeals.

Mr. Siebert updated the Board on Township district signage estimates. Several vendors were discussed with pricing estimates as well as locations and types of signs that could be used for different areas.

Mr. Siebert informed the Board that Warren County is assessing the Hoffman Ave swale. The Township will work with the County to see what if any improvements can be made to the swale.

Mr. Siebert informed the Board that he had a discussion with the Engineers Office that no additional stop signs could be added to Shaker Run and that they are not in favor of speed bumps or speed humps. However, he did say the Township could add speed limit signs, a digital sign but preferably it would be moveable. He also said speed limits painted on the road are an option. The Trustees are waiting on a letter from the Shaker Run Homeowners Association for their input.

#### Administration:

Mrs. Boggs requested a Resolution to authorize Jonathan Sams, Trustee Chairperson to sign the agreements to receive the U.S. Department of the Treasury Coronavirus State and Local Fiscal Recovery Funds and Assurance of Compliance with Civil Rights Requirement for American Rescue Plan Act of 2021 agreements to receive the American Rescue Plan Act of 2021 funding and agree to accept the ARP Funds. Mr. Jones made a motion, seconded by Mr. VanDeGrift, to approve the Resolution as stated above. All present voiced a "YEA" vote and the motion was passed with **Resolution 21-07-06.** (A copy of the Resolution is included in the minutes.)

Mrs. Boggs requested ratification for expenditures authorized by Township Administrator or Township Officer or Employee authorized by Township Administrator in the cumulative amount of \$395.53. The purchases are \$98.95 from Amazon, \$123.50 from State of Ohio Pharmacy, \$24.90 from Reflective Apparel Factory, \$148.18 from The Home Depot. Mr. VanDeGrift made a motion, seconded by Mr. Jones to subsequently approve the expenditures in the cumulative amount of \$395.53. All present voiced a "YEA" vote and the motion was passed with **Resolution 21-07-07.** (A copy of the Resolution is included in the minutes.)

The Board discussed the City of Lebanon's request for annexation of property on the west side of State Route 63. The current annexation agreement states we will wait for five years to begin collecting reimbursement income. Mrs. Boggs informed the Board that the City will work with the Township on a memorandum of understanding for future annexations.

Mrs. Boggs informed the Board that the PUD standards for Core 5 may have some changes. Mrs. Boggs expects more information to be forthcoming from zoning. Mrs. Boggs will report back to the Board regarding this matter.

Mrs. Boggs informed the Board that a letter was received from Warren County Regional Planning regarding the final plat for Shaker Run Section 9. Mr. Siebert commented that he wants the road construction to have an aggregate base, storm sewer signs, no parking on the hydrant side of the streets, no parking in cul-de-sacs, and no final road topcoat until substantially complete. The Trustees agreed with Mr. Siebert's comments. (A letter will be sent to Warren County Regional Planning stating this information).

Mrs. Boggs informed the Board that a letter was received from Warren County Regional Planning regarding Union Village Phase 1B Final Plat. Some lot numbers have been changed. Mrs. Boggs will include comments to include the road construction to have an aggregate base, storm sewer signs, no parking on the hydrant side of the streets, no parking in cul-de-sacs, and no final road topcoat until substantially complete. (A letter will be sent to Warren County Regional Planning stating this information).

Mrs. Boggs informed the Board that a letter was received from Warren County Rural Zoning with a variance request for Bruce Goseclose on State Route 48. Mr. Goseclose wants to build a garage in front of his house. The Trustees want to see the plans before commenting. Mrs. Boggs will request the plans from Warren County Rural Zoning.

Mrs. Boggs informed the Board that a letter was received from Warren County Rural Zoning with a variance request for Robert Singleton on State Route 63. Mr. Singleton wants to build a garage in front of his home as he is handicapped and needs this flat location for the garage. The Trustees had no comments. (A letter will be sent to Warren County Regional Zoning stating this information).

Mrs. Boggs informed the Board that the RFQ for Station 31 remodel project received one bid from KZF. Mrs. Boggs will get more information to determine the next steps.
