TURTLECREEK TOWNSHIP BOARD OF TRUSTEES

ON SEPTEMBER 13 21

The regular scheduled meeting of the Board of Trustees of Turtlecreek Township was held on September 13, 2021 at 7:00 p.m. with the following persons present:

TRUSTEES: Jonathan Sams, Dan Jones and Jim VanDeGrift

FISCAL OFFICER: Amanda Childers

GUEST: Tammy Boggs, Mike Jameson, Brian Elleman, Dave Siebert and Mike Shaffer.

The meeting opened with Mr. VanDeGrift leading the Pledge of Allegiance.

The minutes of the meeting held on August 31, 2021 were received by the Trustees prior to the meeting for review. Since there were no additions or corrections, Mr. Jones moved for acceptance, seconded by Mr. VanDeGrift. All were in favor and the minutes were approved as written.

The Fiscal Officer notified the Trustees that the financial reports for the previous month were available for their review. By motion of Mr. Jones and seconded by Mr. VanDeGrift the following reports were approved. Cash Summary by Fund (month to date and year to date), Fund Status Report, and Bank Reconciliation for the previous month.

Department Reports:

Fire/EMS:

Michael Jameson, Fire Chief, gave the Board an update on his time with Task Force One which was deployed to Louisiana ahead of the hurricane.

Chief Jameson informed the Board that the EMS Equinox needs to be replaced and asked for authorization to sell it on GovDeals. Chief Jameson explained the vehicle take down schedule with the purchase of a new Chief vehicle, then shifting the Suburban to the Battalion Captains and then shifting the Yukon to take the place of the Equinox. Chief Jameson will get pricing and time frame for delivery for the new vehicle. Mr. VanDeGrift made a motion, seconded by Mr. Jones to approve listing the Equinox on GovDeals with a minimum bid of \$4,800.00. All present voiced a "YEA" vote and the motion was passed.

Chief Jameson informed the Board that the Warren County Career Center is looking for out of date turnout gear for education purposes only and will not be used in any fire related activity. Mr. Sams directed that a gift letter would need to include the transfer of ownership and the agreement that once the Warren County Career Center is done, proper disposal by destruction will occur. Mr. Jones made a motion, seconded by Mr. VanDeGrift to approve gifting the out of date turnout gear to Warren County Career Center as described above. All present voiced a "YEA" vote and the motion was passed.

Chief Jameson discussed the dates when an open house for the new Station 33 can occur. More information will be forthcoming as plans develop.

Dan Jones informed the group that he toured Station 31 in its current state to have a better understanding of the need for renovation. Station 31 was changed to full time (24 hour) staffing last year and the result is better response time for the east side of Turtlecreek Township. The foundation and size of the vehicle bays is adequate so it makes sense to renovate Station 31 as soon as possible.

Road and Bridge:

Dave Siebert, Road and Bridge Supervisor, informed the Board that Shaker Run Boulevard is torn up from the construction vehicles. We are working with the Warren County Engineer's Office for solutions.

Mr. Siebert updated the Board on the Storm Water Management Modeling for the Hoffmann swale as the consultant's cost and time frame for completion have changed. The Engineer's Office informed Mr. Siebert that the cost of the study has increased to \$8,600.00 and is expected

to take two months to complete. They believe the Warren County Storm Sewer Funds will pay for the study even with the increase in cost.

Mr. Siebert informed the Board that Station 33 needs landscaping. The budget has \$17,000.00 available for that use. Mr. Siebert stated he is getting more bids and will also price the purchase of materials with installation being completed by the Road Department. Several scenarios were discussed and more information will be presented soon.

Administration:

Tammy Boggs, Township Administrator, requested a Resolution to effectuate a temporary tax holiday for tax budge year 2022. The Tax Holiday will reduce the real property taxes from property owners in Turtlecreek Township. The funds waived are our collection on the General fund millage of 0.61 to 0.00 for the 2022 tax year only. The reduction in taxes will not affect the tax increment financing districts. Mr. Jones made a motion seconded by Mr. VanDeGrift to approve the Resolution as stated above. All present voiced a "YEA" vote and the motion was passed with **Resolution 21-08-04.** (A copy of the Resolution is included in the minutes.)

Mrs. Boggs requested ratification for expenditures authorized by Township Administrator or Township Officer or Employee authorized by Township Administrator in the cumulative amount of \$376.99. The purchases are \$159.49 from Apple Support, \$214.51 from Taoglas USA Inc. and \$2.99 from Amazon. Mr. VanDeGrift made a motion, seconded by Mr. Jones to subsequently approve the expenditures in the cumulative amount of \$376.99. All present voiced a "YEA" vote and the motion was passed with **Resolution 21-09-03.** (A copy of the Resolution is included in the minutes.)

Mrs. Boggs informed the Board that we received a notification from Warren County Regional Planning regarding Shaker Run Section 9 Easement Plat. The Trustees had no comments or concerns. (A letter will be sent to Warren County Regional Planning regarding this matter.)

Mrs. Boggs informed the Board that we received a notification for the Ribbon Cutting Ceremony for the Warren County Jail to be held on October 12, 2021 at 9:30 a.m.

Mrs. Boggs informed the Board that the Warren County Amateur Radio Association requested use of the meeting room for the remainder of this year and next year for their monthly meetings. Mr. VanDeGrift made a motion, seconded by Mr. Jones to approve the use of the meeting room for the remainder of this year and 2022 by the Warren County Amateur Radio Association. All present voiced a "YEA" vote and the motion was passed.

Mrs. Boggs informed the Board that it is time to look at development for the East side of the Township. A work session will be planned soon.

Mr. Jones made a motion, seconded by Mr. VanDeGrift to accept the Amounts and Rates as determined by the Budget Commission. All present voiced a "YEA" vote and the motion passed with **Resolution 21-09-01** (a copy of the resolution will be included in the minutes).

Mrs. Childers requested a line item transfer from within the EMS Fund from 2191-930-930-0000 (Contingencies) to 2191-230-599-0005 (Training) in the amount of \$10,000.00 for needed expenses. Mr. VanDeGrift made a motion, seconded by Mr. Jones to approve the line-item transfer. All present voiced a "YEA" vote and the motion passed with **Resolution 21-09-04.** (A copy of the resolution will be included in the minutes).

Mrs. Childers requested the Board to approve the 2021 Amended Permanent Appropriations. The amendment includes the addition of the Coronavirus Local Fiscal Recovery Funds. Mr. VanDeGrift made a motion, seconded by Mr. Jones to approve the 2021 Amended Permanent Appropriations. All present voiced a "YEA" vote and the motion passed with **Resolution 21-09-05**. (A copy of the resolution is included in the minutes.)

Mrs. Childers informed the Board that Ohio Deferred Compensation has requested that payroll payments be made through the Ohio Business Gateway by electronic method rather than by warrant.

Be it further resolved, to hereby notify the Warren County Auditor, Warren County Budget Commission, and the public that the requested temporary reduction in levies shall have no practical effect on the tax increment financing districts of Turtlecreek Township as Section 5709.74(A) of the Ohio Revised Code requires that if any reduction in the levies otherwise applicable to exempt property within the tax increment financing districts is made by the county budget commission, the amount of service payment in lieu of tax shall be calculated as if a reduction in levies had not been made.
