The regular scheduled meeting of the Board of Trustees of Turtlecreek Township was held on October 11, 2021 at 7:00 p.m. with the following persons present:

TRUSTEES: Jonathan Sams and Jim VanDeGrift (Dan Jones was absent) FISCAL OFFICER: Amanda Childers GUEST: Tammy Boggs, Brian Elleman, Dave Siebert, John Paul Campbell, Mike Shaffer, Ryan Woodward and Connor Fulkerson.

The meeting opened with Mr. Sams leading the Pledge of Allegiance.

The minutes of the meeting held on September 28, 2021 were received by the Trustees prior to the meeting for review. Since there were no additions or corrections, Mr. VanDeGrift moved for acceptance, seconded by Mr. Sams. All were in favor and the minutes were approved as written.

The Fiscal Officer notified the Trustees that the financial reports for the previous month were available for their review. By motion of Mr. VanDeGrift and seconded by Mr. Sams the following reports were approved. Cash Summary by Fund (month to date and year to date), Fund Status Report, and Bank Reconciliation for the previous month.

Department Reports:

Fire/EMS:

Brian Elleman, Assistant Fire Chief, informed the Board that we received a resignation from Tyler Polen effective September 28, 2021.

Assistant Chief Elleman informed the Board that he received an email from a resident thanking Matt Helton and Jeff Dahlhoff for the fantastic job they did when they responded to a call.

Road and Bridge:

Dave Siebert, Road and Bridge Supervisor, informed the Board that Shaker Run calming measures include installed speed limit signs, painted speed limit signs on the roadway and children at play signs. Speed limits are now displayed every 750 feet. Additionally, the digital sign has been ordered.

Mr. Siebert informed the Board that we are still waiting to hear from the Engineer's office regarding the Hoffmann Swale.

Mr. Siebert informed the Board that the new Track Hoe is enroute for delivery. The trailer is not expected to arrive until December.

Mr. Siebert informed the Board that the Equinox did not meet the reserve bid on GovDeals. The highest bid was \$4,000.00 with the reserve set at \$4,800.00. The Trustees decided to relist the Equinox again with the reserve of \$4,800.00.

Administration:

Tammy Boggs, Township Administrator, informed the Board that the ribbon cutting for the new Warren County Jail is October 12th at 9:30 a.m. with tours following afterward.

Mrs. Boggs requested the Board amend Resolution 20-09-12 to adopt Appendix D of the 2017 Fire Code. Appendix D does not automatically incorporate into the 2017 Fire Code and requires a separate legislative act to do so. The provisions contained within Appendix D involve fire apparatus access roads and requirements. Mr. VanDeGrift made a motion, seconded by Mr. Sams to approve the Resolution as stated above. All present voiced a "YEA" vote and the motion was passed with **Resolution 21-10-01.** (A copy of the Resolution is included in the minutes.)

Mrs. Boggs requested ratification for expenditures authorized by Township Administrator or Township Officer or Employee authorized by Township Administrator in the cumulative amount of \$1,563.87. The purchases are \$320.79 from Amazon, \$47.96 from Lowe's, \$82.92 from Home Depot, \$55.93

from Domino's\$552.68 from RelaDyne and \$503.59 from Pavement Stencil Company. Mr. VanDeGrift made a motion, seconded by Mr. Sams to subsequently approve the expenditures in the cumulative amount of \$1,563.87. All present voiced a "YEA" vote and the motion was passed with **Resolution 21-10-02.** (A copy of the Resolution is included in the minutes.)

Mrs. Boggs informed the Board that we received a snowplow agreement from Meade Building Group for Hudson Estates Subdivision. Mr. VanDeGrift made a motion, seconded by Mr. Sams to approve the agreement to begin plowing the undedicated streets of the Hudson Estates subdivision for Meade Building Group. All present voiced a "YEA" vote and the motion was passed.

Mrs. Boggs informed the Board that we received a notification from Warren County Zoning Department of a variance request for Ms. Stovall at 536 N. Waynesville Road requesting approval of a new front porch that is larger than zoning allows. The Trustees had no comments or concerns. (A letter will be sent to Warren County Zoning regarding this matter.)

Mrs. Boggs informed the Board that she received a letter from Warren County Regional Planning for the Shaker Run Section 8A Final Plat. The Fire Chiefs requested turnarounds in the cul-desacs. (A letter will be sent to Warren County Regional Planning stating this information).

Mrs. Boggs informed the Board that she received a letter from Warren County Regional Planning regarding Core5-75 Logistics Center North Preliminary Plan. The Trustees requested that the road construction be consistent with Park North and that the access point to Union Road be established as soon as available to the developer. (A letter will be sent to Warren County Regional Planning stating this information).

Mrs. Boggs informed the Board that she received a letter from Warren County Regional Planning for Greentree Meadows PUD Stage 2 also known as the Frasik property. The Trustees request minimum square footage of construction and lot size as stated in the PUD rezoning letter. The Township would also request that turnarounds or cul-de-sacs be added to all stub streets and no parking posted by the developer on the hydrant side of the street. (A letter will be sent to Warren County Regional Planning stating this information).

Mrs. Boggs informed the Board that a letter was received from Keever Creek's attorney requesting that we reconsider the removal of the rock in the right of way. The Trustees still want it to be removed. (A letter will be sent to Keever Creek's attorney stating this information).

Mrs. Boggs informed the Board that the Health Department would like to host a tire recycling event at the Administration building next year. The Trustees were amenable to the request.

TOPIC OF RESOLUTION: AMENDING RESOLUTION NUMBER 20-09-12 ADOPTING APPENDIX D OF THE 2017 OHIO FIRE CODE, AND ANY AMENDMENTS THERETO, AS PART OF THE LOCAL FIRE CODE FOR ADMINISTRATION AND ENFORCEMENT IN TURTLECREEK TOWNSHIP, WARREN COUNTY, OHIO

RESOLUTION

WHEREAS, in accordance with section 505.373, a board of trustees may, by resolution,

adopt by incorporation by reference a standard code pertaining to fire, fire hazards, and fire prevention prepared and promulgated by the state or any department, board, or other agency of the state, or any such code prepared and promulgated by a public or private organization that publishes a model or standard code, and subsequently adopt any amendment or change thereto by incorporation by reference; and,

WHEREAS, on September 29, 2020, this Board adopted Resolution Number 20-09-12 establishing the 2017 Ohio Fire Code, and the 2019 Updates, for administration and enforcement as the local Fire Code in Turtlecreek Township, Warren County, Ohio; and,

WHEREAS, the aforementioned legislation does not automatically incorporate Appendix D of the 2017 Ohio Fire Code, and requires a separate legislative act to do so; and,

WHEREAS, upon the recommendation of the Turtlecreek Township Fire Chief, this Board desires to make Appendix D of the 2017 Ohio Fire Code (attached hereto), and any amendments thereto, a part of the local Fire Code for administration and enforcement in Turtlecreek Township, Warren County, Ohio.

THEREFORE, BE IT RESOLVED, by the Board of Turtlecreek Township Trustees, Warren County, Ohio, at least a majority of the Trustees casting a vote concur as follows:

- **Section 1**. That the Board does hereby amend Resolution Number 20-09-12 adopting Appendix D of the 2017 Ohio Fire Code, as part of the local Fire Code which shall be administered and enforced by the Turtlecreek Township Fire Department, officials, and their designees, in the unincorporated territory of Turtlecreek Township, Warren County, Ohio.
- <u>Section 2</u>. The Township Fiscal Officer shall cause a notice that this Board has adopted Appendix D as part of the local Fire Code to be enforced in Turtlecreek Township, Warren County, Ohio, stating

the purpose of the Code, and stating that a complete copy of the Code is on file with the Township Fiscal Officer for inspection by the public and also by posting a link on the Township's website for the general public to access the Code, without charge, and further, the Fiscal Officer shall post said notice in five conspicuous places in the Township for 30 days before coming effective. The notice shall also be posted in a newspaper of general circulation in the Township once a week for three consecutive weeks.

- **Section 3.** That the Board is acting in its legislative capacity in adopting this resolution, and such legislation shall take effect on the 30 days after the date of adoption of this resolution.
- **Section 4**. That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.
- Section 5. That it is found and determined that all formal actions of the Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of the Board in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
